## Notice to All Stakeholders

Semi-Annual Review of Industry Experience as of June 2020 for  
Private Passenger Vehicles

### Purpose:

The Automobile Insurance Rate Board (AIRB) is issuing this notice to advise all stakeholders the AIRB has commenced consultation on its 2021 semi-annual review for private passenger vehicles. This review analyzes industry loss experience as of June 2020 for private passenger vehicles to establish Industry Benchmarks used in the review of insurers' rate filings for basic and additional coverage effective April 1, 2021.

### Background:

Section 9 of the Automobile Insurance Premiums Regulations requires the AIRB to conduct an annual review. In addition, the AIRB believes it should be using the most current available data in its review of rate filings and as such conducts a semi-annual review.

### Process:

1. The AIRB requests its consulting actuary, Oliver, Wyman Limited, to complete a first draft Review of Industry Experience (as of June 30) for private passenger vehicles, once the data is available.
2. The AIRB consults with interested stakeholders on the draft report once available. The draft report posted to the AIRB [website](#) to allow all stakeholders the opportunity to review. This Notice initiates the consultation process, and provides stakeholders a timeline to provide input by written submission to the AIRB.
3. The AIRB staff and consulting actuary review all comments received, and the consulting actuary will update their report based on any new information provided by stakeholders and submit a final report to the AIRB.
4. The AIRB will review and approve the final report, and issue a Bulletin to all Stakeholders providing industry benchmarks used in its review of insurers' rate filings effective April 1.
